HEDIS® Advanced Illness and Frailty Exclusion Guide

Purpose

The National Committee for Quality Assurance (NCQA) allows certain **HEDIS and STAR measure exclusions** for members with **advanced illness, frailty, or palliative care needs**. These exclusions recognize that some preventive or disease-management measures may offer limited benefit—or create unnecessary burden—for members with significant clinical complexity.



Who May Be Excluded

Members may be excluded from select HEDIS measures when claims data shows evidence of **advanced illness, frailty, or palliative care**, as defined by NCQA value sets.

Why it Matters



Advanced illness and frailty are important considerations in healthcare quality because they affect patient outcomes, care needs, and care delivery. NCQA recognizes that some HEDIS measures may not be appropriate for patients with these conditions. For that reason, certain measure exclusions are allowed, and identify patients' ability to manage their health condition at home in order to optimize their quality of life.

Patients may be excluded when there is evidence of the following:

Advanced Illness (Exclusions may be identified in current or prior year claims.)	Either two indications of advanced illness on at least two different dates of service for severe chronic conditions such as emphysema, cirrhosis, leukemia, heart failure, dementia, and end-stage renal disease or a dispensed dementia medication.
Frailty (Must be identified in the measurement year.)	At least two indications of frailty with different dates of service during the measurement year for conditions such as pressure ulcers, durable medical equipment usage, or services such as home health and skilled nursing, which are indicators of limited mobility or physical functionality.
Palliative Care (Requires only one qualifying claim.)	Patients receiving palliative care.

Exclusions must be supported by valid claims data. Medical records alone cannot be used for advanced illness or frailty exclusions (except for palliative care).

Coding and Documentation Requirements

- **Claims-based data only** is used to identify advanced illness and frailty exclusions.
- Acceptable encounters include in-person visits, telehealth and telephone appointments, and e-visit/virtual check-ins.
- Reduce medical record requests and improve submission accuracy by using **NCQA-approved ICD10, CPT, and HCPCS codes**.
